

CONSTITUTION

Preamble:

We, the members of **Karachi Nojawan Party**, in our unwavering commitment to the principles of justice, equality, and democracy, unite to form a political party dedicated to the advancement of a just and prosperous society.

Recognizing the inherent dignity of every individual and the inalienable rights of all people, we pledge to uphold and protect the fundamental freedoms and opportunities that empower each person to contribute to the common good.

In pursuit of a more equitable and inclusive society, we affirm our dedication to fostering economic opportunity, social justice, and environmental stewardship. We strive to build a future where every voice is heard, every community is respected, and every citizen can thrive.

With resolute purpose, we commit ourselves to democratic governance, transparent leadership, and active participation in the political process. We seek to inspire and mobilize a diverse coalition of citizens who share our vision for a better future, and to engage in constructive dialogue and collaboration to achieve our collective goals.

In this spirit, we establish this constitution to guide our actions, define our principles, and set forth our mission. Through our shared values and collective efforts, we aim to create a society that reflects the highest ideals of justice and humanity.

The **Karachi Nojawan Party** will establish National, provincial and district bodies.

NAME:

The association takes the name of **Karachi Nojawan Party**.

Symbol:

The symbol of the political party is **Barn Swallow – Ababeel**.

AIMS AND OBJECTIVES:

- 1. Upholding Islamic Values by virtue of the Constitution of Islamic Republic of Pakistan:** To promote and uphold the principles of Islam as outlined in the Quran and Sunnah, ensuring that all policies and practices reflect the ethical and moral values of Islam.
- 2. Establishing Justice and Equity:** To strive for a just and equitable society by implementing policies that address social and economic inequalities, safeguard the rights of all citizens, and promote fairness and integrity in governance.
- 3. Fostering Economic Development:** To advance economic development through sustainable practices, innovation, and the equitable distribution of resources, ensuring that economic policies align with Islamic teachings and benefit all segments of society.

- 4. Promoting Social Welfare:** To enhance social welfare by supporting programs and initiatives that provide for the needs of the disadvantaged, promote education, healthcare, and social services, and strengthen the social fabric of the nation.
- 5. Strengthening Democracy and Governance:** To reinforce democratic processes and institutions within the framework of Islamic principles, ensuring transparent, accountable, and participatory governance that reflects the will of the people.
- 6. Preserving Cultural and Religious Heritage:** To protect and celebrate the cultural and religious heritage of the Islamic Republic, promoting the values of tolerance, mutual respect, and cultural diversity within the context of Islamic teachings.
- 7. Ensuring National Security and Sovereignty:** To safeguard the nation's security and sovereignty through effective policies and strategies that maintain peace, protect against external threats, and promote national unity.
- 8. Encouraging Civic Engagement and Responsibility:** To foster an active and informed citizenry by encouraging civic engagement, responsibility, and participation in the democratic process, and by promoting the principles of Islamic ethics in public life.
- 9. Promoting International Cooperation:** To engage in constructive and respectful international relations, fostering cooperation with other nations while upholding Islamic principles and national interests.
- 10. Enhancing Environmental Stewardship:** To advocate for environmental protection and sustainable development, ensuring that environmental policies reflect the Islamic principle of stewardship of the earth and contribute to the well-being of future generations.

ELEGIBILITY FOR MEMBERSHIP:

Membership of the *Karachi Nojawan Party* shall be open to all adult citizens of Pakistan who are not members of any other political organization.

Signs a declaration that he/she is in agreement with the aims and objects of the Karachi Nojawan party and will abide by its rules and constitution.

Each member of the party shall pay an annual fee upon joining and in any event not later than 2 months.

The membership fee of the party will be RS/100 and the party will issue the membership card and the certificate to each member of the party.

Elected members will pay fee as determined in the Parliamentary group. This fee will be collected by the Finance Secretary and/or officers designated from time to time by the President of the party.

Only the members of the party will be allowed to become the office bearers.

RESPONSIBILITIES:

a) PRESIDENT

The President is the administrative and organizational head of the Party in the Center and the province

b) VICE PRESIDENT

In the absence of the President, the Vice President will preside over meetings and exercise the powers of the President.

c) GENERAL SECRETARY

The Secretary General will record the minutes of the meetings. He will be assisted by the deputy secretary generals of the party.

d) INFORMATION SECRETARY

The Information Secretary will communicate the views of the Karachi Nojawan Party Parliamentarians and correct distortions.

e) SECRETARY FINANCE

He will open the Party bank account accordingly, maintain the accounts and collect fees from the members of the executive and council. Each member of the Central, Provincial and District Committees will pay an annual fee of Rs. 2,00000 except in case of exemption, failing which he will lose his membership.

The Chairman of the party (The Leader) shall be elected by the direct secret ballot of all the Members on the register/database of party

The election of chairman will be held every 4 years before the general elections of the country.

Incase if the party is failing to elect its chairman and the position is vacant it is the responsibility of the Secretary General to take the additional charge and make sure that the chairman is elected within 30 days.

Moreover, the elections of the other office bearers will be held every 2 years and they will be given designated positions according to the secret ballot elections held by the members of the party.

The members will be specified for each region (wings) after the results of the election.

The organization of the Karachi Nojawan Party shall consist of the following specialized wings:

- Women Wing.
- Youth Wing.
- Minority Wing
- Lawyers Wing
- Trade and Industry Wing.
- Business and Commerce
- Labor Wing
- Teachers wing
- Social Media Wing
- Cultural Wing
- Kisan Wing

TERMINATION OF MEMBER BY THE KARACHI NOJAWAN PARTY:

1) Those violating the conditions for eligibility of the Karachi Nojawan Party will cease to be members of the political party.

2) The members are given free will to speak on the given forum. Differences in opinion are a natural aspect of democratic freedom, but they must still align with the framework set by the Party.

3) Political parties are groups organized to achieve specific objectives. If a dispute arises between members, including issues of suspension or expulsion, the member will be removed from the party in the interest of the Karachi Nojawan Party overall goals.

4) Efforts will be made to reconcile members by the office bearers or committees shall be formed to eradicate such disputes to avoid the termination of the members.

FINANCE AND ACCOUNTS

Membership Fee:

Each member shall remit 80% of its income from membership fees or other sources to the Karachi Nojawan Party.

Party Ticket Fee:

1) The chairman may establish the fees for candidates seeking party tickets for Senate, National Assembly, Provincial Assembly, Local Council elections, and by-elections. These fees must be paid via a cross cheque or pay order.

2) Therefore, all the funds will be deposited to the bank given by the Karachi Nojawan Party.

3) The finance secretary will be responsible to operate all the bank account.

4) No unauthorized accounts may be maintained in the name of Karachi Nojawan party. Any violation of this rule will result in strict disciplinary action taken by the Party against the responsible individual.

5) No donation, contributions or funds (in any form) will be accepted from foreigners, multinational or domestically incorporated public or private company, firm, trade or professional associations. Party will only accept donations from party workers and Pakistani citizens.

Constitutional changes

Members are authorized to propose amendments to the Constitution, provided that such changes are fully aligned with and support the core objectives and foundational principles upon which the Karachi Nojawan Party was established. All proposed amendments must be consistent with the Party's mission and vision, ensuring that they enhance and further the overarching goals of the organization.

Policy for party election

- Elections for the offices of the Karachi Nojawan Party will be held every four years or as stipulated by the Federal Organization.
- Only members who are in good standing and demonstrate adherence to the Party's objectives will be eligible to run for office or to cast their vote
- The electoral process will be governed by a voter list that includes members residing in the relevant geographic area for the election, whether Federal, Provincial, or District.
- This ensures that all electoral activities are conducted in a manner that reflects the Party's commitment to its organizational structure and democratic principles.

Procedure for Legislative elections

Members who have consistently demonstrated an active commitment to advancing the aims of the Karachi Nojawan Party who maintain a status of good standing, will be considered eligible to contest elections. This eligibility is contingent upon the fulfillment of the following criteria:

a. **Credibility as a Candidate:** The member must have established credibility and demonstrated potential for electoral success, ensuring that they are a viable candidate capable of achieving a favorable outcome in the elections.

b. **Public Record:** The member must have a proven public record of support for the principles espoused by Quaid-e-Azam this record should reflect a consistent alignment with the foundational values and principles of the Party.

c. **Commitment to Loyalty and Integrity:** The member must provide a formal undertaking to uphold loyalty to the Party, actively resist any forms of political horse trading, and maintain integrity in their conduct and affiliations.

RESPONSIBILITIES OF MEMBERS:

- All members must adhere to the Party's constitution.
- All members are expected to respect the Party's inspirational figures and consistently conduct themselves in a manner befitting parliamentary standards.
- No member is allowed to use or exploit party name, fame and office for its personal gains or benefits.
- A member may stand for office and vote, provided they have cleared all outstanding dues and meet the qualifications specified in the Party's objectives.
- Office bearers and Provincial Organizations must submit quarterly performance reports of members or progress of the party to the Party President.
